Position Description

TAC is seeking an Associate II to assist with management and implementation of our contract to support Massachusetts' Medicaid Children's Behavioral Health Initiative (CBHI) training and quality improvement efforts. This position will support TAC's CBHI Project Manager and Project Director by providing overall coordination and logistical support for the CBHI practice review process and for training, coaching, product development, and additional workforce support identified by CBHI and MassHealth. The ideal candidate has experience working in the Massachusetts child service system, MassHealth behavioral health services, or CBHI. An appreciation for and willingness to learn about related policy and systems-level issues, in support of TAC's broader work related to Medicaid and behavioral health, is desired.

Responsibilities

- Participate in the assessment of client consultative needs and provide direct technical assistance, consulting, and training activities for TAC clients as assigned with increasing independence.
- Work productively under the direction of senior staff, and in collaboration with other TAC staff and partners, to provide comprehensive, client-focused services and the alignment of supportive services with affordable housing as applicable.
- Conduct research to support client consultative needs through data analysis, key informant interviews, and participation in focus groups with increasing independence, and interpret/apply to client issues or needs.
- Support and facilitate groups with a range of stakeholders including people with lived experience, service and/or housing program managers, senior level government officials, etc.
- Develop presentations and speak publicly in community meetings, conferences, or other venues as identified by senior staff.
- Interact with and maintain relationships with clients and partners.
- Participate in and support project management of MassHealth CBHI contract, including contract compliance, coordination of team member activities, budget oversight, and completion of project reports and other deliverables, depending on experience.
- Support projects related to the MassHealth CBHI contract, including initiatives such as the Massachusetts Practice Review, statewide and regional System of Care meetings, Intensive Care Coordination and In-Home Therapy trainings, and engagement with higher education institutions to support CBHI workforce development efforts.
- Perform all assigned duties on-time and within budget, as directed by CBHI Project Director and Project Manager.
- Support other TAC staff and consultants in areas of relevant subject matter expertise, through monitoring emerging issues and trends in the field and researching, analyzing, and summarizing data and information on topics of interest to TAC staff and clients, while developing increased subject matter expertise and successfully applying it to client work.

Qualifications

- Minimum five years of experience in government, managed care, policy and/or provider roles in fields of mental illness, substance use disorders, Medicaid, and/or human services within the state of Massachusetts. Additional work or lived experience may substitute for work experience.
- Experience with best practices in mental health, substance use disorder and/or other disability systems and policy.
- Experience working in the Massachusetts child service system, MassHealth behavioral health services, or CBHI.
- Knowledge of best practice program design, financing, and implementation and the diverse needs of people with mental illness and substance use disorders.
- Ability to work independently as well as in a team environment, both within the organization and with external partners and clients.
- Self-directed, organized team member with demonstrated time management skills and the ability to meet deadlines and timelines; project management experience preferred.
- Communication skills, including strong writing and public speaking.
- Demonstrated ability to think strategically and to apply skills/knowledge/expertise to client issues or concerns.
- Ability to understand, communicate, and effectively interact with people across various cultures.
- Ability to understand, work with, and interpret data.
- Bachelor's degree in a related field (social work, psychology, or related health profession) required; advanced degree encouraged. Additional work or lived experience may substitute for bachelor's or advanced degree.
- Flexibility to travel within state to monthly project meetings and trainings, and to perform other project-related activities as needed.
